#### 1. OVERVIEW

A risk assessment must be undertaken by a competent person before using the GLOVE™ Foot.

Fitting a sling under the thigh of a heavy user in a wheelchair can be very difficult. A GLOVE™ Foot support sling can be easily cupped around the heel of a person whilst they are in a wheelchair and attached to a hoist. This enables their leg to be raised to ease the fitting of their sling under their thigh.

Using a GLOVE™ Foot support sling also reduces the risk of back injury for carers, and the possibility of inadvertently causing discomfort to the user if the leg is bent or twisted when being lifted.

#### 2. PRODUCT CARE

#### 2.1 SLING INSPECTION:

- 2.1.1 Care & Independence recommend pre-use sling checks by competent person and this includes for any accessories.
- 2.1.2 As slings are Class One Medical Devices, they are subject to Lifting Operations and Lifting Equipment Regulations Examinations. A LOLER examination may only be conducted by a person trained and qualified to do so. The LOLER examination also applies to the GFOOT.

### 2.2 LAUNDERING:











- We recommend washing gently at 40°C. Use a mild soap solution or a non-biological detergent without bleaching additives. For more robust decontamination purposes, the GFOOT may be washed at up to 95°C.
- Do not add bleach or stain removers.
- Air dry, cabinet dry or tumble dry on a cool cycle (below 60°C). Do not tumble dry on a hot setting.
- Do not place on hot pipes or heaters. Keep away from flames.
- Do not iron.

#### 3. HOW TO APPLY

Always support the foot until the straps have been adjusted to the correct position

- i. Place the user's heel in the aperture see image below.
- ii. Attach the straps to the hoist.
- iii. Once the leg is in the correct position, adjust the sliders to hold the GLOVE™ Foot in place.

NOTE: Typically, a leg weighs 1/6 of the total body weight.
